Most members of the security forces acted with impunity. Although the crisis erupted in Mali, most countries in the region face the same threats to peace and security. No refugee policy was issued by year's end, and resettlement remained suspended.

Many of the present constitutions contain elements of what is needed to make participation of women and minorities : No laws limit the participation of women or members of minority groups in the political process. Five Latin American governments and Canada urged the ICC to open an investigation of crimes in Venezuela – the first time that any governments have sought an ICC investigation of crimes that took place entirely outside their territory.

The president appointed its members, increasing executive control of the judiciary. The study also supported the definition and implementation of targeted interventions adapted to households or people affected by HIV in the lake region in Chad, where high rates of acute and chronic malnutrition were registered.
